

Dru Ayurveda Online Foundation Course (DAOFC) Terms and Conditions

- 1. You should uphold the International School of DRU Yoga (DRU Ayurveda is taught as part of the school of Dru Yoga) to the best of your ability, and not act in any way that may bring discredit to the School.
- 2. All students and graduates are expected to abide by the Code of Conduct of the DAOFC.
- 3. You must agree to practise DRU Ayurveda in accordance with the standards of safety set by your tutors.
- 4. During the Course your tutors make ongoing evaluation and assessment of your suitability for continued participation in the course. This is discussed with each student when necessary in the event of any areas of concern in relation to their continued participation, as necessary throughout the course. If it is the view of the Course tutors that any student should not continue with the Course at any time (whether that view be to defer the student's further participation or simply brought to a permanent conclusion), we reserve the right to end that student's participation in the Course and the decision of the Course tutors shall be final. In this case, no further course fees or cancellation fee will be payable by the student.
- 5. The Course involves a wide variety of Ayurveda techniques, and you agree to take responsibility for your health and well-being by respecting your body's limitations and health conditions you may have by:
